# Course Outlines

---

## Option 1—Four One-Carnegie-Unit Courses

This curriculum consists of four one-credit courses, which should be completed in the following sequence:

1. **Furniture Design and Manufacturing I– Course Code: 993502**
2. **Furniture Design and Manufacturing II– Course Code: 993503**
3. **Furniture Design and Manufacturing III– Course Code: 993504**
4. **Furniture Design and Manufacturing IV– Course Code: 993505**

### Course Description: Furniture Design and Manufacturing I

This course is an introduction to furniture manufacturing. Other topics covered include safety, tool and equipment identification and use, measurements, patterns and layouts, and cutting and assembling frames. This course is requisite to Furniture Design and Manufacturing II.

### Course Description: Furniture Design and Manufacturing II

This course is a continuation of Furniture Design and Manufacturing I. Topics covered include measuring, laying out, and cutting fabrics, sewing procedures, and furniture upholstery. This course is requisite to Furniture Design and Manufacturing III.

### Course Description: Furniture Design and Manufacturing III

This course is a continuation of Furniture Design and Manufacturing II. Topics covered include furniture padding, hardware, and support system components; advanced furniture frame patterns and layout; cutting and assembling frames; measuring, laying out, and cutting fabrics. This course is requisite to Furniture Design and Manufacturing IV.

### Course Description: Furniture Design and Manufacturing IV

This course is a continuation of Furniture Design and Manufacturing III. Topics include applying a working drawing and preparing a bill of materials.

This curriculum consists of two two-credit courses, which should be completed in the following sequence:

1. **Furniture Manufacturing & Upholstery I —Course Code: 993500**
2. **Furniture Manufacturing & Upholstery II —Course Code: 993501**

### **Course Description: Furniture Manufacturing & Upholstery I**

Furniture Manufacturing & Upholstering I is the entry level course of the secondary Furniture Manufacturing & Upholstering program. Students in this course will gain foundation competencies related to orientation, safety, leadership, tool and equipment identification and use, measurement, furniture frame patterns and layout, cutting and assembling frames, and special topics in furniture manufacturing and upholstery. This course is requisite to Furniture Manufacturing and Upholstery II.

### **Course Description: Furniture Manufacturing & Upholstery II**

Furniture Manufacturing & Upholstering II is the exit level course of the secondary Furniture Manufacturing & Upholstering program. Students in this course will gain additional skills related to upholstery tools; furniture padding, hardware and support system components; measurement, layout, and cutting of fabrics; sewing procedures, furniture upholstery; and special topics in furniture manufacturing and upholstery.

# Research Synopsis

---

## Introduction

Manufacturing is a vital industry in Mississippi, and manufacturing jobs in the state are projected to remain stable over the next ten years. Manufacturing in general employs nearly 12 percent of the workforce in the state. Furniture manufacturing, the largest manufacturing industry in Mississippi, accounts for over 18,000 jobs and about 70,000 indirect and induced jobs.

Mississippi manufactures and ships more upholstered furniture than any other state in the nation (Mississippi Department of Employment Securities, 2014). Other countries, such as China, regard furniture products made in the U.S. as being of the highest quality, thus providing Mississippi furniture manufacturers an opportunity to develop export markets and expand export sales (Franklin Furniture Institute of Mississippi State University, 2013). North Mississippi has the highest concentration of furniture manufacturers in the state (Seddon, 2014).

## Needs of the Future Workforce

Furniture manufacturing jobs in the United States are expected to decrease over the next 10 years, however, furniture manufacturing jobs in Mississippi are expected to increase. Although the number of upholsterers in Mississippi is projected to decrease by 2020, the occupational projections data indicates an annual demand of 100 upholsterers for both new positions and for replacing those who leave or change occupations (Mississippi Department of Employment Securities, 2012). Employment opportunities for occupations related to furniture manufacturing are listed below.

## Perkins IV Requirements

## **Curriculum Content**

### **Summary of Standards**

The standards to be included in the Furniture Design & Manufacturing curriculum are the Common Career Technical Core Standards, College and Career Readiness Standards for English Language Arts and Mathematics, 21st Century Skills, and the National Educational Technology Standards (NETS) for Students. Combining these standards to create this document will result in highly skilled, well-rounded students who are prepared to enter a secondary academic or career and technical program of study. They will also be prepared to academically compete nationally as the College and Career Readiness Standards are designed to prep students for success in community colleges, Institutions of Higher Learning and careers.

### **Academic Infusion**

The Furniture Design & Manufacturing curriculum is tied to the College and Career Readiness Standards for English Language Arts and Mathematics. The curriculum provides multiple opportunities for students to apply and reinforce the core academic skills required in the workforce and to further their education at the postsecondary level. Students will apply mathematical reasoning, critical thinking, and problem-solving techniques to work-related problems as they progress through the program. Students will also be required to locate, synthesize, and use information from charts, tables, forms, diagrams, and instrument gauges. Students will sharpen their reading comprehension skills as they locate and interpret written information. The location of the College and Career Readiness standards for each unit is located in Appendix E.

### **Best Practices**

#### *Innovative Instructional Technologies*

Recognizing that today's students are digital learners, the classroom should be equipped with tools that will teach them in the way they need to learn. The Furniture Design and Manufacturing curriculum includes teaching strategies that incorporate current technology. Each classroom should incorporate one teacher desktop or laptop as well as student computers in a networked environment. Each classroom should be equipped with an interactive white board and projector, intensifying the interaction between students and teachers during class. Teachers are encouraged to make use of the latest online communication tools such as wikis, blogs, and podcasts. They are also encouraged to teach using the content-delivery system Canvas, which introduces students to education in an online environment and places the responsibility of learning on the student.

#### *Formative Assessment*

Formative assessments, or assessments *for* learning, are part of the learning process and do need to be graded (like summative assessments or assessments *of* learning). In the formative assessment process, teachers check for understanding during classroom instruction and adjust teaching and learning while they are still happening. This also allows students to see what success looks like and gives them the opportunity to do better.

### *Higher Order Thinking*

A main goal of education today is to teach students the skills they need to be critical thinkers. Instead of simply memorizing facts and ideas, students need to engage in higher levels of thinking to reach their fullest potential. Practicing higher order thinking (HOT) skills in the classroom will give students the tools that they need to understand, infer, connect, categorize, synthesize, evaluate, and apply the information they know to find solutions to new and existing problems. Instructional strategies should focus on improving students' higher order thinking competencies, including critical evaluation, creative thinking and reflection on their own thinking. Mastery of higher order thinking skills will also prepare students for the 21st century workplace.

### *Differentiated Instruction*

Differentiation means addressing the needs of academically diverse learners in our increasingly diverse classrooms. The use of multiple instructional strategies is more likely to reach out effectively to varied students than using a single approach to teaching and learning. Teachers are particularly limited when the sole or primary instructional strategy is teacher-centered (such as lecture), or drill-and-practice (such as worksheets). Whether teachers differentiate content, process, products, or the learning environment, the use of ongoing assessment and flexible grouping makes this a successful approach to instruction.

### *Project-based Learning*

Project-based learning is a systematic teaching method that engages students in learning knowledge and skills through authentic or “real-world” projects. Students should be given the opportunity to work relatively autonomously over extended periods of time on activities that culminate in realistic products or presentations.

### *Cooperative Learning*

There is an ever-increasing need for interdependence in all levels of our society. Providing students with the tools to effectively work in a collaborative environment should be a priority. Cooperative Learning is a well-researched instructional strategy and has been reported to be highly successful in the classroom. Using cooperative learning strategies is one way of providing students with a well-defined framework from which to learn from each other while simultaneously learning academic and social skills.

### **Conclusions**

Based on the previous information, the Furniture Manufacturing & Design curriculum will be filled with opportunities to develop workforce skills. Widely used teaching strategies, such as cooperative learning, problem-based learning, and demonstration, will also be included. These will help to prepare students for the hands-on instruction they will likely receive upon entering the workforce. The curriculum document will be updated regularly to reflect the needs of the Furniture Manufacturing & Design workforce.

## **Suggested Time on Task**

Graph exponential and logarithmic functions, showing intercepts and end behavior, and trigonometric functions, showing period, midline, and amplitude.

F-IF.9 Compare properties of two functions each represented in a different way (algebraically, graphically, numerically in tables, or by verbal descriptions). For example, given a graph of one quadratic function and an algebraic expression for another, say which has the larger maximum.

### Build new functions from existing functions
