Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The proposed amendments to "Air Emissions Operating Permit Regulations for the Purposes of Title V of the Federal Clean Air Act", APC-S-6 involve amendments to conform with state law changes specifically "Senate Bill 2812" which removes the maximum amount of annual Title V permit fees that may be assessed to an air emission source subject to Title V. Prior to this state law change, the maximum annual fee that could be assessed to a facility was \$250,000. This amendment does not change the minimum annual fee of \$250, nor does it change the maximum emission rate of each pollutant used in the calculation of fees, which is four thousand (4,000) tons per year per facility
