Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This proposed rule will amend the present regulations to take final action to adopt the Revisions to the Export Provisions of the Cathode Ray Tube (CRT) Rule promulgated by EPA on June 26, 2014, the Hazardous Waste Management System: Conditional Exclusion for Carbon Dioxide (CO2) Streams in Geologic Sequestration Activities promulgated by EPA on January 3, 2014, and the Hazardous Waste Management System; Modification of the Hazardous Waste Manifest System; Electronic Manifests Rule promulgated by EPA on February 7, 2014.

Specific legal authority authorizing the promulgation of rule: Mississippi Code Annotated 49-2-9(1)(b) Rev. 2003




