**LETTER OF CAUTION**

The Charities Division of the Mississippi Secretary of State’s Office (“Division”), on behalf of the Secretary of State, has the power to administer and to enforce the Mississippi Charitable Solicitation Act (“Act”), Miss. Code Ann. Section 79-11-501 *et seq.* Pursuant to its jurisdiction, the Division hereby issues this Letter of Caution against Entertainment Publications, LLC.

***Parties:***

C. Delbert Hosemann, Jr. is the duly elected Secretary of State for the State of Mississippi.

Entertainment Publications, LLC is a “fund-raising counsel” as defined in Miss. Code Ann. Section 79-11-501(e).

***Jurisdiction:***

The parties herein acknowledge and submit to the jurisdiction of the Secretary of State as to the parties and the subject matter of this Letter of Caution.

***Facts:***

1. Entertainment Publications, LLC is an organization registered with the Division as a fund-raising counsel.
2. Entertainment Publications, LLC’s registration expires on June 30, 2013

3. As a registered fund-raising counsel, Entertainment Publications, LLC acknowledges that it should not receive or have control or custody over funds, directly or indirectly, including having a fund/account that it has control over where contributions are deposited.
4. Entertainment Publications, LLC acknowledges that in July of this year, it entered into an agreement with Oxford Elementary School where sales were conducted through online sales and brochure sales; however, Oxford Elementary School received no cash contributions for the online sales as all contributions from online sales were received by Entertainment Publications, LLC in violation of the law. Oxford Elementary School did receive a credit equal to forty percent (40%) of the online sales. This credit was applied to the balance owed to Entertainment Publications, LLC by the school for the products received.
5. Entertainment Publications, LLC acknowledges that online sales took place due to the fact that the Oxford account was not marked as a Mississippi account. These online sales shouldn't have occurred.
6. While the Division has no reason to doubt that a mistake was made by Entertainment Publications, LLC regarding the Oxford account, this agreement took place in violation of the Mississippi Charitable Solicitation laws.
7. Entertainment Publications, LLC has indicated that this mistake will not happen in the future as it is discontinuing the Sally Foster project line this year.

On the basis of the above, the Division hereby issues this **LETTER OF CAUTION** to Entertainment Publications, LLC and cautions that it should remain in compliance with the Act pursuant to Miss. Code Ann. Section 79-11-501 *et seq.*

***Requirements & Agreements:***

The Division and Entertainment Publications, LLC agree that Entertainment Publications, LLC will comply with the Mississippi Charitable Solicitation Act and Rules promulgated thereunder.


The Division and Entertainment Publications, LLC further agree that Entertainment Publications, LLC will review all of its accounts in which it acts a professional fund-raiser or

fund-raising counsel in Mississippi to ensure it is in compliance of the laws with the Mississippi Charitable Solicitation Act and Rules promulgated thereunder.


The Division will impose a penalty of One Thousand Dollars (\$1,000.00) against Entertainment Publications, LLC for violation of the Act.

The parties herein acknowledge that they have read the terms of this Letter of Caution, which is complete, and they agree to comply with all the terms herein. The parties further agree that any change, modification, or alteration of this document may only be done in writing and must be agreed to by all parties.
