## LETTER OF CAUTION

Dear Ms. Coogler:

The Charities Division of the Office of the Secretary of State of the State of Mississippi (“Division”), on behalf of the Secretary of State, having the power to administer and to enforce the provisions of the Mississippi Regulation of Charitable Solicitations Act, Miss. Code Ann. § 79-11-501, *et seq.* (“Act”) and Act Rules (“Rules”) hereby issues this Letter of Caution to PICO National Network (“PICO” or “Respondent”).

### *Parties*

1. C. Delbert Hosemann, Jr., is the duly elected Secretary of State for the State of Mississippi (“Secretary”).
2. PICO is a charity, organized under the laws of the State of California and registered in the State of Mississippi.

*Jurisdiction*

3. The parties herein acknowledge and confess to the jurisdiction of the Secretary of State as to the parties and the subject matter of this Letter of Caution.
4. PICO acknowledges that the Division has jurisdiction over entities and individuals soliciting charitable donations in Mississippi and from Mississippi residents.

*Facts*

5. PICO's Mississippi Charity Registration lapsed on November 31, 2012.
6. After PICO's lapse in Registration and before their current Registration was submitted to the Division, PICO mailed its solicitation appeals.
7. PICO mailed five (5) solicitation appeals to Mississippi residents.
8. PICO did solicit from Mississippi residents during a time that it was unregistered.

*Conclusion of Law*

9. On the basis of the above, the Division hereby issues this **LETTER OF CAUTION** to PICO and cautions that such actions as described in the Facts above may be considered to be violations of PICO's duty to register as a charity (Miss. Code Ann. §§ 79-11-501, *et seq.* (2010)).

*Requirements & Agreements*

The Division and PICO hereby agree to the following:


10. PICO shall pay an administrative fee in the amount of Two Hundred Fifty Dollars (\$250.00).
11. PICO shall not solicit from Mississippi residents, for any reason, while it does not have a current Mississippi Charity Registration on file with the Division.

12. From the date in which PICO signs this Letter and forward, PICO shall maintain strict compliance with the Act and Rules.

The parties herein acknowledge that they have read the terms of this Letter of Caution, which is complete, and they agree to comply with all the terms herein. The parties further agree that any change, modification, or alteration of this document may only be done in writing and agreed to by all parties.
