The Annual Report must be filed with the Secretary of State's Office no later than 5:00 p.m. on Wednesday, January 31, 2018, for the period beginning January 1, 2017 and ending December 31, 2017 by the following:

- All statewide, state district and legislative officeholders who have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann.*; and
- All previous candidates for statewide, state district and legislative office who have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann.*; and
- All political committees which supported or opposed a state, state district or legislative candidate and which have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann*.

An Annual Report also must be filed with the respective Municipal Clerk's Office no later than 5:00 p.m. on Wednesday, January 31, 2018, for the period beginning January 1, 2017 and ending December 31, 2017 by the following:

- All municipal officeholders who have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann.*; and
- All 2017 municipal candidates who have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann.*; and
- All political committees which supported or opposed a 2017 municipal candidate which have not terminated their reporting obligations under *Section 23-15-807(a)*, *Miss. Code Ann*.

January 10, 2018 Periodic Report

This Periodic Report must be filed with the Secretary of State's Office no later than 5:00 p.m. on Wednesday, January 10, 2018, for the period beginning October 1, 2017 and ending December 31, 2017, by *only 2017 Judicial candidates and political committees which supported or opposed a 2017 Judicial candidate*. Termination Report

A termination of reporting obligations pursuant to *Section 23-15-807(a)*, *Miss. Code Ann.* is a campaign finance disclosure report which may have been previously filed by a candidate or political committee simultaneously with another required campaign finance report. A termination report may be filed by a candidate or political committee at any time so long as the candidate or committee represents he/she will no longer receive any contributions or make any disbursements and such candidate or committee has no outstanding debts or obligations.
