

2018 Candidate Qualifying List

Pursuant to Mississippi law, the respective Political Parties determine whether those candidates who submit qualifying papers to the respective party meet the qualifications for office prior to his or her name being placed on the 2018 Primary Election ballots. The State Board of Election Commissioners determine whether each political party nominee (the winners of each Primary Election), independent and non-partisan candidate meets the qualifications for office prior to his or her name being placed on the 2018 General Election ballot.

This candidate list is updated once daily, after 5:00 p.m., and may only reflect those candidates who have submitted qualifying papers but not yet been determined as "qualified" to be placed upon either the Primary or General Election ballot.
