Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: As part of the annual curriculum revision and development process in Career & Technical Education, postsecondary curriculum writing and revision teams (consisting of college faculty, deans and directors, business and industry representatives, and curriculum specialists from Mississippi State University's Research and Curriculum Unit) updated the Practical Nursing Postsecondary curricula. The curriculum was validated by college faculty, deans and directors. The curriculum framework follows the format established for postsecondary career and technical programs. It will be approved for implementation in the 2012-13 school year and must be implemented by August 1, 2014.
