person and for the office set opposite the respective names at said election.

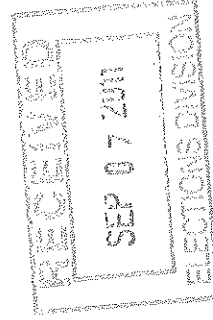
