This proposed filing to the MS Administrative Code Title 23 Medicaid, Part 200 General Provider Information, Chapter 2 Benefits, Rule 2.2.B and C Non-Covered Services is to include the three never events in inpatient hospital (SPA 2011-004), outpatient hospital (SPA 2011-006) and other types of healthcare settings (SPA 2012-001). Non-substantive revisions are being made to Rule 2.2A.




