Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This filing includes language to correspond with SPA 2013-032 approved by Centers for Medicare and Medicaid Services (CMS) on August 8, 2014, which allows for an additional payment for certain services during extended office hours outside the Division of Medicaid's definition of "office hours" and removes Federally Qualified Health Center (FQHC) and FQHC look-alike encounters from the physician visit limit of twelve (12) visits per state fiscal year.

Per Miss. Code Ann. § 25-43-3.109 Rule 1.4: Pregnancy Related Eligibles is being amended on this final filing to comply with 42 CFR § 435.116, 42 CFR Part 491 and SPA 13-0019.

Specific legal authority authorizing the promulgation of rule: 42 CFR §§ 435.116, 440.230, Part 491; Miss. Code Ann. § 43-13-121; SPA 2013-032, SPA 13-0019.




