Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This filing is to include coverage language for the Measles, Mumps, and Rubella (MMR) and Varicella vaccines according to the indications and guidelines of the Centers for Disease Control and Prevention (CDC) for beneficiaries nineteen (19) and older. Non-substantive changes made to Rule 1.5 by replacing "Reserved Moved to Miss. Admin. Code" with "Refer to", added a description to the CDC acronym in Rule 1.7 and replaced the word "significantly" with the word "separately" in Rules 1.3 and 1.4.

Specific legal authority authorizing the promulgation of rule: 42 USC § 1396s; Section 2125 of the Public Health Service Act [42 USC §300aa-26]; Miss. Code Ann. §§ 41-23-37, 43-13-121, 43-17-5.
