CONSENT AGREEMENT

I. Jurisdiction

Finding it appropriate and in the public interest, the Regulation and Enforcement Division of the Office of the Secretary of State of Mississippi (hereafter "Division"), on behalf of the Secretary of State, having the power to administer and to provide for the Mississippi Scrap Metal Dealer Act of 2008, Miss. Code Ann. § 97-17-71 to § 97-17-71.2 (hereafter "Act"), and Respondent, Aluminum Recycling of MS, Inc. (hereafter "Respondent"), do hereby enter into this Consent Agreement (hereafter "Agreement"). This Agreement is entered into as a resolution and settlement of a civil administrative charge wherein the Division alleges violations of the Act by the Respondent.

II. Agreement

Respondent admits the jurisdiction of the Division as to all parties and matters herein under the authority of the Act. In consideration of a final resolution of the matters set forth herein, the Division and Respondent hereby agree and stipulate to the following:

1. The Secretary of State has the authority to administer and to provide for the enforcement of all provisions of the Act, which regulates the purchase of regulated metals in the State of Mississippi.
2. As a purchaser of regulated metal property, Aluminum Recycling of MS, Inc., is subject to the requirements of the Act.

10. Respondent and the Division understand that entry of this Agreement represents the settlement of all regulatory claims alleged or which could have been alleged by the Division against the Respondent through June 3, 2015.
11. The Consent Agreement shall not constitute an adjudication of or finding on the merits of the allegations made against the Respondent by the Division and shall not be construed as an admission or acknowledgment by Respondent of any violation of the Act.

III. Acknowledgement

The parties acknowledge that they have read this Agreement in its entirety and fully understand the rights, terms, and obligation of each contained therein and they have been vested with the express authority to enter into this Agreement. The parties further acknowledge that they have not been threatened or otherwise coerced into entering into this Consent Agreement. This Consent Agreement constitutes the complete agreement among the parties with respect to matters referred herein. The Agreement is final and binding upon the parties, their agents, successors, and assigns.

The undersigned hereby acknowledge and agree to the terms and conditions of the foregoing Agreement by written consent.
