**FINAL CEASE AND DESIST ORDER AND
ORDER IMPOSING ADMINISTRATIVE PENALTY**

COMES NOW, Jeffrey Lee, Senior Attorney, Securities and Charities Division of the Mississippi Secretary of State’s Office (“Division”), after serving, by certified mail, a SUMMARY CEASE AND DESIST ORDER AND NOTICE OF INTENT TO IMPOSE ADMINISTRATIVE PENALTY (“Summary Order”) on BOB FORD CHRISTIAN GOLF FOUNDATION, INC. (“BFCGF”); the Division hereby issues this FINAL CEASE AND DESIST ORDER AND ORDER IMPOSING ADMINISTRATIVE PENALTY regarding Respondent’s violations of the Mississippi Charitable Solicitations Act (“Act”).

In its Summary Order, issued on or about February 24, 2012, the Division alleged that:

1. BFCGF failed to maintain proper books and records in violation of Miss. Code Ann. Section 79-11-518, and Mississippi Charitable Solicitations Act Rule 213;

2. BFCGF's board members individually violated their respective fiduciary duties to the charity in violation of Miss. Code Ann. Section 79-11-215;
3. BFCGF violated an order entered by the Secretary of State pursuant to the Mississippi Charitable Solicitations Act when it violated a Consent Agreement entered between itself and the Division on January 29, 2010.

WHEREAS, BFCGF wholly failed to respond to the Summary Order and request a hearing of the matter within the time allowed by the Act;

WHEREAS, service of process of the Summary Order was made in full compliance with the applicable state statute and rule and was signed for and accepted by one Willie Shoto on February 24, 2012;

WHEREAS, the allegations of the Summary Order were not contested, and it is therefore found that BFCGF has violated the aforementioned provisions of the Act;

WHEREAS, BFCGF was advised in said Summary Order that, in the event written notice requesting a hearing of the matter was not received within thirty (30) days of service of the Summary Order, that a FINAL CEASE AND DESIST ORDER AND ORDER IMPOSING ADMINISTRATIVE PENALTY may be entered without further notice;

IT IS THEREFORE ORDERED, pursuant to the authority set out in the Act, that the registration of BOB FORD CHRISTIAN GOLF FOUNDATION, INC. is hereby revoked and that the organization shall permanently **CEASE AND**


DESIST from soliciting charitable donations in Mississippi and from all further illegal activity;

IT IS FURTHER ORDERED, pursuant to authority set out in the Act, that an administrative penalty of Two Thousand Five Hundred Dollars (\$2,500.00) is imposed against Respondent BOB FORD CHRISTIAN GOLF FOUNDATION, INC. Said penalty is to be paid within thirty (30) days from the date of this Order.


