ORDER LIFTING FINAL CEASE AND DESIST ORDER

THE SECRETARY OF STATE OF MISSISSIPPI, by and through the undersigned representative, hereby issues this Order Lifting Final Cease and Desist Order issued against FOUNDATION FOR MORAL LAW, INC. (hereinafter "Respondent"). In support thereof, the Secretary of State would show the following:

I. JURISDICTION

The Secretary of State is vested with the regulation of charitable solicitations pursuant to Miss. Code Ann. Sections 79-11-501, et seq. (Supp. 2010) (the "Act"). The Respondent is a charitable organization as defined by the Act and is, therefore, subject to the Secretary of State's regulatory authority. The Secretary of State has jurisdiction over this matter and the persons herein.

II. FACTS AND LAW

1. The Secretary of State issued a Summary Cease and Desist Order against Respondent on May 26, 2004. Respondent was served with a certified copy of the Summary Order.
2. Respondent failed to request a hearing or otherwise respond to the Summary Order within thirty (30) days as prescribed in the Act.
3. A Final Cease and Desist Order was therefore issued against Respondent on July 6, 2004.

3. Respondent has sought renewal of its charity registration and has satisfied the Act's requirements and paid appropriate fines stemming from the Summary and Final Orders. The Final Order issued on July 6, 2004 is hereby lifted.

III. PUBLIC INTEREST

The actions taken and proposed to be taken herein by the Secretary of State are in the public interest and are consistent with the purposes set out in Miss. Code Ann. § 79-11-501, et seq. (Supp. 2010).


IV. RIGHT TO AMEND


