CONSENT ORDER

This Consent Order is entered into by the State of Mississippi, Office of the Secretary of State, Business Regulation and Enforcement Division (“Division”) and Steve R. Anderson (“Anderson”).

Anderson is an adult resident of the State of Mississippi residing at 8 South Point, Hattiesburg, Mississippi 39402.

Preliminary Statement

1. On or about March 2003, the Division received complaints regarding the activities of Anderson. Specifically, the complainants alleged that Anderson offered and sold an investment opportunity in lines of credit representing that such investment would return ten percent (10%) per month.

2. Anderson currently holds a life insurance license in the State of Mississippi. He is not, however, registered with the Division as either a broker-dealer agent or investment adviser representative.


3. The interests sold by Anderson were not registered as securities with the Division nor are they exempt from registration.

Anderson agrees to comply with all the agreements, stipulations and/or undertakings herein, and the Division reserves the right to seek enforcement of this Order by application to Chancery Court of Hinds County, Mississippi, First Judicial District, upon a determination by the Division that Anderson has failed to comply with the terms of this Consent Order.

ORDER BY STEVE R. ANDERSON**




Steve R. Anderson states that no promise of any kind or nature whatsoever was made to it to induce it to enter into this Order and that it has entered into this Order voluntarily.


