

**Candidate Qualifying List**

**This list only reflects the names of those candidates who have submitted qualifying papers to the office of the Secretary of State.** Pursuant to Mississippi law, the State Board of Election Commissioners determine whether each candidate meets the qualifications for the office sought prior to his or her name being placed on the General Election Ballot.

Political Party Candidates for U.S. President, U.S. Senate, and U.S Representative file qualifying papers with their respective State Party Executive Committee. Pursuant to Mississippi law, the respective Political Parties determine whether those candidates who submit qualifying papers for U.S. Senate and U.S. Representative to the respective party meet the qualifications for office prior to his or her name being placed on the 2024 Primary Election Ballots. Pursuant to Miss. Code Ann. Section 23-15-1091, the Mississippi Secretary of State will place Presidential Preference Primary candidates on the ballot who meet the requirements of Miss. Code Ann. Section 23-15-1093. This list is updated once daily after 5:00 p.m.
