Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This Administrative Code adds language which prohibits providers from billing the Division of Medicaid for providing or accessing records substantiating services provided and claims submitted as is required by the Provider Agreement. It also revises the retention of records providers who are required to submit cost reports from five (5) years to three (3) years in compliance with Senate Bill 2836 effective July 1, 2018. Specific legal authority authorizing the promulgation of rule: M42 C.F.R § 422.504; Miss. Code Ann. §§ 43-13-117, 43-13-118, 43-13-121, 43-13-129.




