Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This Administrative Code is being filed to mirror Medicare's coverage and reimbursement of HBOT which: (1) allows for direct supervision of HBOT by a non-physician practitioner (NPP), (2) allows for coverage and reimbursement per beneficiary session of physician or NPP attendance or supervision of HBOT, (3) defines the cardio-pulmonary response (CPR) team, and (4) revises the coverage of medical conditions to those Food and Drug Administration (FDA) approved or that follow medically accepted indications supported by one (1) or more of the official compendia as designated by the Centers for Medicare and Medicaid (CMS) or the Undersea and Hyperbaric Medical Society (UHMS).
