Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Changing rule from requirement that alcoholic beverage be made inside permitted premises to allow for telephone orders and payments and curbside pickup during a state of emergency or event that Commissioner of Revenue determines curbside pickup should be allowed.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h). "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."



