Short explanation of rule amendment/repeal and reason(s) for proposing rule amendment/repeal:

Proclamation suspending the provisions of *Miss. Code Ann. § 73-7-7* requiring Board of Health approval for sanitation rules created to deal with the COVID-19 pandemic. Proclamation also suspends *Miss. Code Ann. § 73-7-37*'s limit of \$500 for fines for rules created to address the COVID-19 pandemic. Suspension of these provision is necessary for quick implementation of temporary rule 7.16, which establishes penalties for opening in violation of an executive order of the governor.
