The Plan is to be effective July 1, 2020, based upon Legislative requirements of implementation of the Plan.

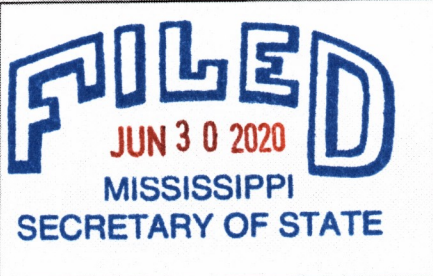
