Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Amendment 1 to the FFY-2020 Intended Use Plan is an extension of the Drinking Water Systems Improvements Revolving Loan Fund (DWSIRLF) Program's loan application deadline to June 1, 2020 in response to the outbreak of COVID-19 in the State of Mississippi. This extension will allow loan applicants that submitted applications after the May 1st deadline due to delays caused by the pandemic to maintain their priority funding obligations.

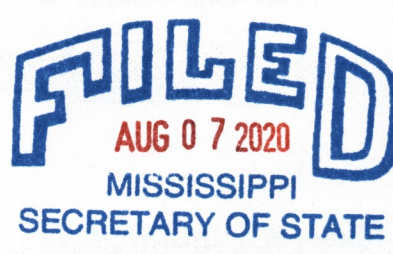
