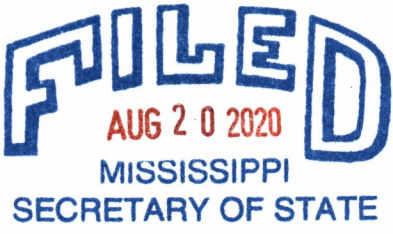

Compilation filing for clarification purposes. R. 1.1 amendment prohibits use of non-disposable hard cards and deletes all other language. R. 1.2 amendment deletes all language about non-disposable cards and changes the minimum value to charge for card faces. R. 2.3 amendment adds language about ticket prices and minimum paybacks. Rule 3.1(b) amendment and language about submitting session reports via electronic mail. Rule 3.1(l) amendment deletes all language about under 18s. R. 4.1 amendments change payout amounts for video bingo and maximum allowable bets and adds language about minimum payouts not being less than the amount bet. R. 4.2 amendments change payout amounts for video pull-tabs and maximum allowable bets and adds language about minimum payouts not being less than the amount bet. R. 4.3(l) amendment deletes all language about under 18s. R. 4.7(b) adds language about machines awaiting Commission approval.
