Attachment to SOS APA Form 1:

Compilation filing for clarification purposes. R. 1.1 amendment adds definitions of "bingo location" and adds to definitions of "net proceeds" and "pull-tabs." R. 1.1 amendment also addresses where duplicate copies of records shall be kept and changes the minimum number of hours of traditional bingo play. R. 1.2(c) amendment addresses distributor's license fees for table top and handheld electronic dauber units per month. R. 2.1 amendment adds language about waivers for documented charitable activity. R. 2.3 amendment deletes all language about exemptions. R. 3.1 amendment allows for a change in supplies after an audit and changes the number of days from delivery before payment is required. R. 5.3 amendment adds language regarding electronic transfers, changes the amount of the prize payout threshold, adds language about sending reports via electronic mail, and adds language about records kept for progressive pull-tab jackpots. R. 5.5(b) amendment deletes language about exemptions for religious and veterans organizations regarding bingo proceeds. R. 5.5(m) amendment adds language about the 60/40 requirement in relation to Covid-19.
