Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This Administrative Code filing (1) removes the two (2) or more hospitalizations from the coverage requirements of remote patient monitoring, (2) adds the required information for prior authorization, if it's required, (3) adds diabetes type II as a covered diagnosis for continuous glucose monitoring (CGM), and (4) revises the coverage requirement for CGM which corresponds with Medicare coverage. C. Data and Methodology

1. Please briefly describe the data and methodology you used in making the estimates required by this form. *The anticipated economic impact of this filing for federal fiscal year (FFY) 21 is \$108,029 in federal dollars and \$30,897 in state dollars and for FFY 2022 \$435,172 in federal dollars and \$120,532 in state dollars. This estimate was calculated utilizing claim's data from state fiscal year (SFY) 19 for beneficiaries with the diagnosis of diabetes type II with long-term insulin usage which totaled 2,275. The estimates were based on (10%) of these beneficiaries meeting all the requirements for CGM and utilizing the supplies allowance, one time education session, monthly analysis/interpretation of data and cost of the CGM device over a three (3) year period. It is anticipated that the number of emergency department visits as well as inpatient hospital stays and complications from diabetes will decrease with access to CGM which will result a saving of state and federal dollars not included in this estimate.*
