Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This Administrative Code is being filed to (1) add language allowing FQHCs and RHCs to act as a originating and distant site and (2) and for FQHCs, RHCs, and CMHCs to receive both the distant site and originating site fees when such services are appropriately provided by the same organization, in compliance with Miss. Code § 43-13-117, as amended by MS Senate Bill 2799. This final file includes additional originating and distant providers and revises the requirement of a telepresenter as determined by the Division of Medicaid.
