Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule is being amended to include requirements of the Military Family Freedom Act and the Universal Recognition of Occupational Licenses Act and a typo in Rule 1.1.B. This rule is also being filed as a temporary rule to be effective immediately as it affects the public health and safety. Specific legal authority authorizing the promulgation of rule: Miss. Code Ann., Section 73-17-7(2); Miss. Code Ann., Section 73-50-1 and Section 73-50-2; Miss. Code Ann., Section 25-43-3.108. In addition, this rule is being amended to include paragraph A.(12) providing authority of an applicant to request a pre-licensure determination by the Board pursuant to the Fresh Start Act. This rule is also being filed as a temporary rule to be effective immediately as it affects the public health and safety. Specific legal authority authorizing the promulgation of rule: Miss. Code Ann., Section 73-17-7(2); Miss. Code Ann., Section 73-77-9; Miss. Code Ann., Section 25-43-3.108.
