The addition of this new rule (Rule 3.4.4) is necessary to comply with the new Universal Recognition of Occupational Licenses Act of 2021. Relabeling of Rule 3.4.4 to Rule 3.4.5. Amend Rule 3.9.1(8) to comply with the Harris v. Anthony et al, lawsuit. List all rules repealed, amended, or suspended by the proposed rule: Rule 3.1.3, Rule 3.4.4, Rule 3.4.5, and Rule 3.9.1

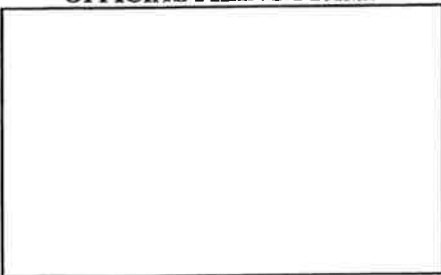
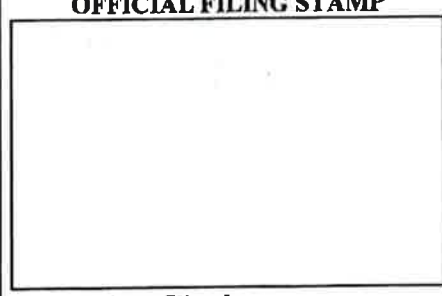
