Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The amendments would add Section 1.28 *Self Directed Brokerage Account* to provide a definition for "Self Directed Brokerage Account," amend Section 6.1 *Investment Options and Group Trusts* to allow the Self Directed Brokerage Account, amend Section 7.10 *Location of Participant or Beneficiary Unknown* to modify the way uncashed checks are handled within the plan, and amend Section 9.2 *Rollovers from this Plan* to allow rollovers to Simple IRAs.

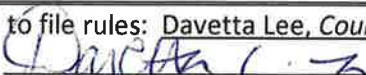

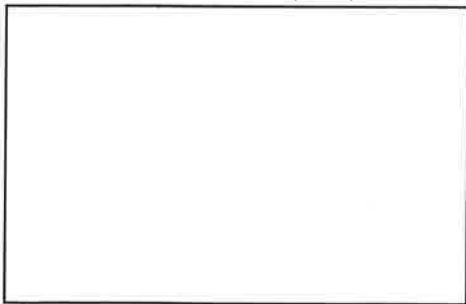
