RESOLUTION

Whereas, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review: NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on March 9, 2022, and may now be filed as final with the Secretary of State's Office for inclusion in the Mississippi Administrative Code:

- Rules of the Board of Optometry – Title 30, Part 2901, Chapters 1-11; HB 1302. *Approved as amended to clarify whether 'days' are calendar days or working days and whether 'year' is a calendar year or otherwise.*
- Rules of the Autism Board – Rules 1.2, 1.3(f), 13.1, 14.1, 15.1, 16.1, 17.1; Change (Amend) the principal office location, New Open Meetings Rule, New Public Records Request Rule, new Executive Session Rule, new Rule for the Licensing of Military-Trained Counselors and Military Spouses, and new Rule to comply with Fresh Start Act of 2019. *Approved as amended to correct the Board's address and various grammatical errors.*
- Rules of the Board of Architecture – Title 30, Part 203: Interior Design Advisory Committee to the Mississippi State Board of Architecture; Amend Rule 2.4 to bring the rule into compliance with the "Universal Recognition of Occupational Licenses Act" (HB 1263, 2021 Regular Session); amend Rule 6.3 to update the Board's website address; and adopt new Rule 6.8 to incorporate by reference the disciplinary rules for the Board of Architecture.

- Rules of the Board of Medical Licensure – Part 2640: Rules Pertaining to Prescribing, Administering, and Dispensing of Medication, Rule 1.14 Pain Management Medical Practice; Lifting of the permanent prohibition against practicing in pain if the licensee has previous discipline related to prescribing controlled substances and to allow CME to be obtained via video conferencing.
