RESOLUTION

Whereas, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review: NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on August 17, 2022, and may now be filed as final with the Secretary of State's Office for inclusion in the Mississippi Administrative Code:

- Rules of the Board of Licensed Professional Counselors - Title 30, Part 2201, Rules 1-9; Composite Rule changes to reduce existing regulations and requirements for licensure to create parity for current Mississippi Licensees due to § 73-50-2. Universal Recognition of Occupational Licenses Act, to simplify and clarify existing rules throughout the document, as well as to make grammatical edits throughout the document. *Approved as amended to change the language of Rule 4.1 K. 9. to "There shall be no waiver opportunities for any conviction involving any form of Abuse of a Vulnerable Adult or Child Abuse, including but not limited to child pornography, enticement, physical abuse, sexual abuse, and neglect. This also includes any conviction under the Child Exploitation Act (Mississippi Code Annotated Section 97-5-33)."*
