Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The MS Board of Nursing seeks amendment of Part 2840, Rule 1.3 to modify the monitored practice hour requirements for APRNs. The MS Board of Nursing additionally seeks amendment of Part 2840, Rule 1.5(K)(4) and Rule 1.5(K)(5) to require in-office drug screening three times per year for patients prescribed benzodiazepines and/or opioids for chronic medical and/or psychiatric conditions which are non-cancer/non-terminal.
