Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: A 2023 amendment to MS Code sec. 73-25-17, effective July 1, 2023, will change application fee amounts charged by MREC for the real estate broker's license (from \$150 to \$100) and for the real estate salesperson's license (from \$120 to \$100). MREC Rule 2.1 lists these fee amounts and must be amended to reflect the new amounts.

Specific legal authority authorizing the promulgation of rule: MS Code sec. 73-35-35 authorizes MREC to adopt rules/regulations. MS Code sec. 73-25-17 identifies fee amounts chargeable by MREC.

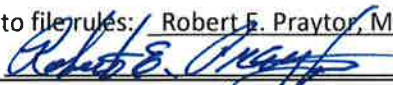

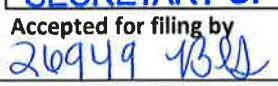
