Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The Office of Health Policy and Planning is amending the COVID-19 MS Local Provider Innovation Grant Program regulations to include the following: 1-1/2% or higher administration cost; update transitional assistance period dates; and adding the statement that grantees can only receive a maximum of \$250,000.
