Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Title 35.II.2.03 - Permitted Premises Where Alcoholic Beverages Are Sold is amended to clarify requirements to request a waiver or an off-site storage exception. Other minor changes were made.

Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
