Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The Mississippi 2024 Section 303(d) List of Impaired Water Bodies identifies those waters within the state for which recent monitoring and assessment have found pollutant specific impairment and for which Total Maximum Daily Loads (TMDLs) are not yet completed. This List is a new regulation that replaces the previous version of this List in its entirety and will be codified at 11 Miss. Admin. Code Pt. 6, Ch. 9.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. §§ 49-2-9(1), 49-17-17, 49-17-19, and 49-17-25 (Rev. 2012)
