Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The proposed amendments to 11 Miss. Admin. Code, Pt. 2, Ch. 2 involve incorporating changes to the federal public notice provisions of the Clean Air Act permitting programs, specifically pertaining to the minor New Source Review (NSR) requirements in 40 CFR Part 51.165. The Ch. 2 amendments also include revisions to provide consistency and clarification to definitions and to streamline the public notice provisions for conciseness. Other minor typographical and editorial changes are also included.
