Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This is an amendment to regulations "Air Emissions Operating Permit Regulations for the Purposes of Title V of the Federal Clean Air Act", to ensure consistency with federal requirements. This amended regulation replaces the previous version in its entirety and will be codified at 11 Miss. Admin. Code Pt. 2, Ch. 6.
