Section 41-59-5 (3), Mississippi Code of 1972, as amended, establishes the Mississippi State Department of Health (MSDH) as the lead agency to establish and maintain a program for the improvement and regulation of emergency medical services. The board is authorized to promulgate and enforce such rules, regulations and minimum standards as needed to carry out the provisions. The proposed changes reflect the national scope of practice for EMS providers. Specific legal authority authorizing the promulgation of rule: Section 41-59-5 (3), Mississippi Code of 1972, as amended

At any time within the twenty-five (25) day public comment period, written submissions including arguments, data, and views on the proposed rule/amendment/repeal may be submitted to the filing agency.
