Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: MDOT wishes to simplify its rules pertaining to the permits that it may offer for over-dimensional vehicles. Following the transfer of the law enforcement functions of MDOT to the MS Department of Public Safety by SB 2825 of the 2021 General Session, MDOT's Law Enforcement Agency was dissolved and the Permits & Motor Carrier Division was created. These rules are specific to this new division.
