Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was amended to reflect an amendment to Miss. Code Ann. §27-65-101 to exempt from Sales Taxation sales, leases, or other retail transfers of fixed-wing aircraft to, or to be used by, certificated common carriers in the transport of person or property in interstate, intrastate or foreign commerce, and engines, accessories and spare parts for such fixed-wing aircraft. These changes were enacted by House Bill No. 1885 during the 2024 regular session.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-65-93, "(1) The commissioner shall, from time to time, promulgate rules and regulations, not inconsistent with the provisions of the sales tax law, for making returns and for the ascertainment, assessment and collection of the tax imposed by the sales tax law as he may deem necessary to enforce its provisions."
