Due to changes to the ASTM Specification D4814 for ethanol blends, changes have been made to the Mississippi Regulations to remain consistent with specifications.

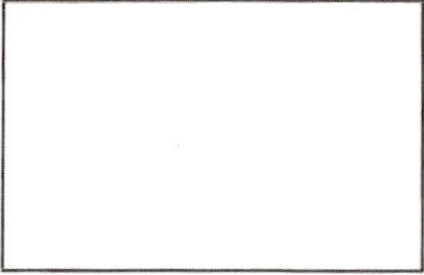
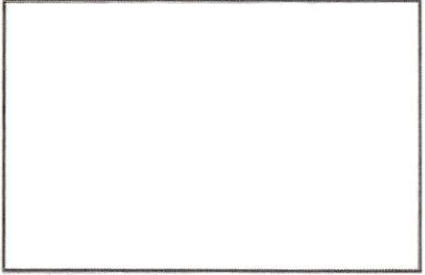
