Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Chapter 03 in Subpart 4 was updated to reflect Senate Bill 2530 which authorizes vehicle owners and drivers to use a business platform for the sharing of vehicles for financial consideration in addition to an amendment to exempt individuals engaging in the program from being able to get temporary car tags. Other minor grammatical and formatting changes were made to Chapters 01, 05, and 06.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 63-21-7(a), The State Tax Commission may, "Promulgate such rules and regulations deemed by it to be appropriate to implement the provisions of the chapter."
