Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: The regulation contains amendments made to Miss. Admin. Code Title 35.IX.01-03. This update was made to account for Internal Department policy changes. The amendment consists of adding a paragraph, cited at 35. IX. 01 (101). This paragraph reflects that taxpayers will be allowed to submit Import Notices via TAP rather than contacting an inspection station operated by the Mississippi Department of Transportation (MDOT). Additionally, formatting and non-substantive changes were made for language and policy consistency.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-55-1, The Department of Revenue, hereinafter called the commission or the department, is hereby vested with the sole power and authority, and is charged with the duty of administering and enforcing the terms and provisions of this article.
