Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Section 41-59-5 (3), Mississippi Code of 1972, as amended, establishes the Mississippi State Department of Health is the lead agency shall establish and maintain a program for the improvement and regulation of emergency medical services. The Board is authorized to promulgate and enforce such rules, regulations and minimum standards as needed to carry out these provisions. The proposed changes would remove UMC and add Institutes of Higher Learning to allow the opportunity for all Mississippi Colleges to provide EMS education.
