RESOLUTION

WHEREAS, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review:
NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on April 1, 2025, and may now be filed as final with the Secretary of State's Office for inclusion in the Mississippi Administrative Code:

- Mississippi State Board of Architecture – Title 30 Miss. Admin. Code, Pt. 202: *Landscape Architecture* – Amend existing rules for conformity with the *Model Regulations* developed by the Council of Landscape Architectural Registration Boards (CLARB), the regulations of the Mississippi State Board of Architecture and the *Model Rules of Conduct* of the National Council of Architectural Registration Boards (NCARB), and to make minor changes.
- Mississippi State Board of Medical Licensure – Title 30 Miss. Admin. Code, Pt. 2625, Ch. 1: *The Practice of Acupuncture* – Revision of existing regulations related to the practice of acupuncture to modernize and comply with statutory changes.
- Mississippi State Board of Licensure for Professional Engineers & Surveyors – Title 30 Miss. Admin. Code, Pt. 901, Chapters 1-9 – Amendment to existing rules to reorganize and for substantial revisions to existing rules to mirror the Model Rules adopted by the National Council of Examiners for Engineers and Surveyors, implementation of the Military Family Freedom Act and Universal Recognition of Occupational Licenses Act.
- Mississippi Board of Pharmacy – Title 30 Miss. Admin. Code Pt. 3001, Article XXXVIII: *Medical Equipment Suppliers Permit* – Amendment to existing regulation regarding the permitting requirements and standards that must be met by medical equipment suppliers doing business in the state of Mississippi.
