Amends §§ 101 and 104 to update the employer contribution rates for the Public Employees' Retirement System and Optional Retirement Program from 17.90% to 18.40% in accordance Senate Bill 3231 as passed during the 2024 Legislative Session and House Bill 1 as passed during the 2025 Legislative session.
