Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: The amendments consist of creating a new chapter for the exemption from ad valorem tax for all-terrain vehicles (ATVs) pursuant to SB 2803 from the 2025 Regular Session. Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-3-31, The Commissioner of Revenue "shall have power and authority to adopt, amend or repeal those rules or regulations necessary and proper to effectively administer the Department of Revenue."
