Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The amendments consist of creating a new chapter for the creation of the Direct Wine Shipper Permit. The permit was created by SB2145 of the 2025 Regular Session and SB2851 of the 2025 Regular Session.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), the Department of Revenue has the authority "[t]o adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders . . . as it deems necessary to control the manufacture, importation, distribution, delivery and sale of alcoholic liquor . . . in a manner not inconsistent with the provisions of this article or any other statute, including the native wine and native spirit laws."
